

**GENERAL INFORMATION CLAUSE ON THE PROCESSING OF PERSONAL DATA
BY THE GDAŃSK ENTREPRENEURSHIP FOUNDATION
IN GDAŃSK**

Based on Article. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (Official Journal of the EU. L 2016 No. 119, p. 1) – general data protection regulation, hereinafter: GDPR/Regulation) the Gdańsk Entrepreneurship Foundation with its registered office in Gdańsk informs that:

- 1. The administrator of personal data is the Gdańsk Enterprise Foundation with headquarters in Gdańsk (hereinafter referred to as: GFP), ul. Lęborska 3b, 80-386 Gdańsk, KRS: 0000234045, NIP: 5832907440, REGON 220049622; phone: 58 731 65 00, e-mail: gfp@gfp.com.pl.*
- 2. A Data Protection Inspector has been appointed in GFP, who can be contacted via e-mail: iod@inkubatorstarter.pl or by phone number 58 731 65 81.*
- 3. Collected personal data, including sensitive data, may be processed by GFP – pursuant to art. 6 clause 1 lit. a) GDPR, i.e. your voluntary and explicit consent to the processing of personal data; based on Article. 6 paragraph 1 lit. b) GDPR – in order to implement civil law contracts concluded with contractors, and in other cases pursuant to art. 6 paragraph 1 lit. c) GDPR in order to implement the tasks and legal obligations incumbent on the Administrator on the basis of generally applicable law.*
- 4. The processing of personal data by GFP takes place for the purposes specified each time in the consent, contract or legal provision, e.g. for marketing and promotional purposes of GFP's activities in the scope of statutory and economic activity, as well as for reporting, settlement, including tax purposes.*
- 5. Personal data are stored by the Administrator for the time necessary to achieve the purpose of their processing, and possibly until the consent to the processing of personal data is withdrawn.*
- 6. The recipients of personal data are entities servicing the administrator in the field of legal, training, educational services, postal operators, hosting providers as well as GFP Content and Media Partners in the implementation of specific education and training projects. The Gdańsk Entrepreneurship Foundation with headquarters in Gdańsk will not transfer personal data to third countries, unless it is required by the implementation of the purpose - about which the information will be in the content of the consent form for the processing of personal data; agreement.*
- 7. The data subject has the right to access, rectify, delete, limit processing, object to their processing, the right to transfer data, as well as the right to lodge a complaint with the supervisory authority. The person whose personal data is processed has the right to withdraw his consent to the processing of personal data, provided that this does not affect the legitimacy of the processing of personal data by the Administrator before withdrawing consent.*
